CALL TO ORDER AND APPROVAL OF MINUTES

Chairman James Lee called the meeting to order at 6:00 p.m. A motion to approve the minutes of the December 18, 2012 meeting was unanimously approved on a motion by Marilyn Atkins seconded by Frank Thurston.

NEW BUSINESS

SUBDIVISION PLAT, AUDIE AND EVELYN MURPHY, OAK GROVE ROAD, TAX MAP 037, PARCEL 1.04, REQUESTING VARIANCE TO ADD LOT TO AN EASEMENT

No one was present to represent the Murphy's request. There was a discussion regarding access to several houses past the Murphy property. The easement that is shown on the Murphy plat begins at Oak Grove Road across the D. Maynard property and the R. Maynard property. The Madisonville Subdivision Regulations state that an easement may be platted for a single lot, 50' in width and that the one lot shall not be further subdivided.

ACTION

Frank Thurston moved to approve the variance to add another lot to the easement. The motion failed for lack of a second.

SUBDIVISION PLAT, ROBERT INGRAM PROPERTY, OLD HIGHWAY 68, TAX MAP 056, MAP 031.00

Surveyor, Brent Cofer represented Mr. Ingram who was also present who requests subdividing his property into 3 lots. Mark Ingram owns property on Old Highway 68 and approximately 1.2 acres would be added to the property. The property has an existing residence and septic system. Lot 2 would be approximately 2.65 acres and an easement is platted for access to Lot 2. Mr. Robert Ingram owns the remaining acreage of approximately 80 acres with remaining road frontage along the highway. The eastern property line of Robert Ingram's property appears to lie within the Floodway as well.

ACTION

Linda Garrett-Hensley moved to approve the plat which was seconded by Shan Harris and approved unanimously.
