# CALL TO ORDER AND APPROVAL OF MINUTES

Chairman Lee called the meeting to order immediately following the Board of Zoning Appeals meeting at 6:07 p.m. Commissioner Garrett-Hensley moved to approve of the July 17, 2018, minutes as presented. Commissioner Atkins seconded the motion and the motion passed unanimously.

## SITE PLAN FOR A-PLUS TIRE, 647 ANDERSON STREET, PARCEL 108.02, MONROE COUNTY TAX MAP 067, LOCATED ON THE SOUTH SIDE OF ANDERSON STREET, APPROXIMATELY 1.64 ACRES, ZONED C-3, FOR THE CONSTRUCTION OF A TIRE STORE (Sid Burrell, Applicant)

Hawk presented the site plan and reviewed the following outstanding items:

- 1. Provide additional detail on the "future storage" (indoor/outdoor/roofed/open-aired, content, etc.).
- 2. Provide minimum access to parking space #31. As shown it is blocked;
- 3. Indicate distance dimension of driveway aisle on east side of building;
- 4. Provide minimum access to parking spaces #27-30. Based on the submitted turning radius template of semi-trailers, they cannot be accessed;
- 5. Increase the landscape island at parking space #26 to 5' wide the full length of the parking space;
- 6. Provide minimum space between lot lines and buildings for future outdoor storage (IFC 3405);
- 7. Provide minimum clearance for fire access around the building (IFC 503.1.1); and
- 8. Provide minimum required access in the storage yard (IFC 3406.2).

A general discussion followed. Sara VanLandingham, Madisonville Fire Department, answered questions regarding the fire code requirements.

Commissioner Saunders moved to approve the site plan subject to addressing the above eight (8) items. Mayor Moser seconded the motion and the motion passed unanimously.

## AMENDMENT TO CHAPTER 2. ZONING CODE, SECTION 11-203. DEFINITIONS, TO ADD AND AMEND DEFINITIONS FOR NEW TERMS USED IN THE ORDINANCE, MADISONVILLE ZONING ORDINANCE

## AMENDMENT TO CHAPTER 4. SUPPLEMENTARY PROVISIONS APPLYING TO ALL DISTRICTS, SECTION 11-402. CUSTOMARY HOME OCCUPATIONS, TO UPDATE HOME OCCUPATION REQUIREMENTS, *MADISONVILLE ZONING ORDINANCE*

Hawk presented Ordinance 18-280-O. Hawk recommended approval of the ordinance. A general discussion followed.
