CALL TO ORDER AND APPROVAL OF MINUTES

SUBDIVISION PLAT, 3-LOTS, JIMMY LEE AND MIKE LEE, MCCLELLAN RD., TAX MAP 133, PARCEL 076.00, APPROXIMATELY 13.05 ACRES, *MADISONVILLE PLANNING* REGION

Chairman Lee summarized the request to subdivide he property into 3 lots of less than 5 acres. Staff noted that setbacks of 30' front and 15' sides and from creek to be shown and Surveyor, Christian Medders, stated he would make hand written notes on the plat.

She stated that they would like to get final approval, however, all the improvements would have to be completed, including roads, water and sewer lines extensions. The planning commission may accept a letter of credit of bond, in lieu of improvements, and that process was discussed. With preliminary approval, all the improvements can proceed, with a request for final when they are completed.
