### CALL TO ORDER AND APPROVAL OF MINUTES

### SUBDIVISION PLAT OF PARCELS 031.00 AND 031.03, MONROE COUNTY TAX MAP 104, LOCATED ON THE SOUTH SIDE OF STAKLEY ROAD AND THE NORTH SIDE OF BIG CREEK ROAD, APPROXIMATELY 30 ACRES, TO SUBDIVIDE OUT 3.18 ACRES AND DISSOLVE OTHER INTERIOR PROPERTY LINES, AND A VARIANCE REQUEST FROM THE MINIMUM BUILDING SETBACK AND EASEMENT REQUIREMENTS, *MONROE COUNTY SUBDIVISION REGULATIONS*, ARTICLE III. C. 4. BUILDING SETBACK LINES AND D. 2. EASEMENTS FOR UTILITIES (Frank Thurston for Robert and Kimberly Richey, Applicant)

The applicant is requesting to place the new property line within 10' of existing buildings. A general discussion followed.
