The commission discussed the template presented of proposed amendments to the RV park regulations which defines a RV park as 2 or more RV's to also mean cabins, tents, yurts or any other form of short-term housing device, and that all spaces shall be a minimum of 40' x 75' and 3,000 square feet in area.
