<u>DISCUSSION OF UPDATING THE TELLICO PLAINS MAJOR ROAD PLAN TO</u> <u>INCLUDE ROADS LOCATED IN THE TELLICO PLAINS PLANNING REGION AREA</u>

Staff distributed a draft list of the classification of all streets. A lengthy discussion followed.

Commissioner Harris moved that the Historic Downtown Streets include all the streets in the area bound by Willowbrook Drive, Harrison Street, Scott Street, Church Street, Smith Street, Swainson Street, Unicoi Lane, Veterans Memorial Drive, Babcock Street, Cherohala Skyway, to Veterans Memorial Drive, back to Willowbrook Drive, but that the Cherohala Skyway would not be included as a Historic Downtown Street, and that the Historic Downtown Streets would have a forty (40) foot right-of-way requirement. Commissioner Johnson seconded the motion and the motion passed 4-0.

Staff will prepare a GIS generated Major Road Plan map for final presentation at a future meeting.
