CALL TO ORDER AND APPROVAL OF MINUTES

Chairman Millsaps called the meeting to order at 6:00 p.m. Commissioner Harris moved to approve the November 2, 2015, minutes as submitted. Commissioner Johnson seconded the motion and the motion passed 3-0, Mayor Hawkins having not yet arrived.

SUBDIVISION PLAT AND HOTEL DEVELOPMENT SITE PLAN, PARCELS 046.10, 046.13, AND 046.14, TAX MAP 146, LOCATED ON THE NORTH SIDE OF BEAR LANE, WEST OF HIGHWAY 68, APPROXIMATELY 4 ACRES, TO DISSOLVE AND MOVE INTERIOR PROPERTY LINES TO ACCOMMODATE HOTEL (James Debernardi, Applicant)

Mr. Debernardi distributed a subdivision plat and presented the project. Staff distributed copies of the draft site plan and an aerial photo of the general area. A general discussion followed.

The following is a brief summary of the discussion:

- The Town maintains Bear Lane to the school property;
- A 2" water line currently serves the site, but a 6" line is needed;
- The best option for water service with a 6" line would be directly from the water tank located on top of the hill behind the development;
- The developer plans to build a retaining wall behind the hotel;
- The hotel will be a Microtel Hotel (Wyndham product) with three-stories and 59 rooms;
- The developer's intent is to construct the building with a rustic façade so as to fit in with the mountain character of Tellico Plains;
- Microtel representatives will be touring the site on Wednesday, December 16;
- The developer's long term goal is to also construct a conference center behind or adjacent to the hotel and to further subdivide the property;
- The presented subdivision plat is a two-lot subdivision which can be reviewed by staff and signed off by the planning commission secretary; and
- The developer is primarily looking for a nod of approval from the planning commission so that this agreement can be relayed to the Microtel representatives.
