### **CALL TO ORDER AND APPROVAL OF MINUTES**

Chairman Millsaps called the meeting to order at 6:02 p.m. Commissioner Atkins moved to approve the February 8, 2016, minutes as submitted. Commissioner Johnson seconded the motion and the motion passed 3-0.

# REQUEST OF RIGHT-OF-WAY ABANDONMENT OF UNICOI LANE BETWEEN SWAINSON STREET AND HIGHWAY 68, ADJACENT TO 305 UNICOI LANE, TAX ID 146H D 001.00, APPROXIMATELY 160 FEET IN LENGTH

Staff presented the request. Unicoi Church Lane and Unicoi Lane were connected prior to the construction of new Highway 68. When Highway 68 was built, Unicoi Church Lane was stubbed into Highway 68 and Unicoi Lane was dead-ended at Swainson Street. The approximately 160 feet of remaining length of old Unicoi Lane has been used as the driveway for the parcel located on the southeast side the right-of-way (Tax ID 146H D 001.00). A creek/drainage way lies between this portion of right-of-way and the neighboring northwestern parcel of Tax ID 146H B 004.01. This has made the 160 foot of Unicoi Lane right-of-way functioning as a part of the southeastern parcel (Tax ID 146H D 001.00). A general discussion followed.

Commissioner Atkins moved to recommend that the Mayor and Board of Aldermen relinquish the approximately 160 feet of Unicoi Lane right-of-way located between Parcels 004.01 and 001.00 to Parcel 001.00 (Tax ID 146H D 001.00) with the stipulation to maintain an easement for the existing utilities. Commissioner Johnson seconded the motion and the motion passed 3-0.

### REVIEW AND APPROVAL OF BY-LAWS OF THE TELLICO PLAINS REGIONAL PLANNING COMMISSION

Staff distributed and reviewed the proposed by-laws. Commissioner Johnson moved to approve the By-Laws of the Tellico Plains Regional Planning Commission. Commissioner Atkins seconded the motion and the motion passed 3-0.

Staff presented the proposed certifications for existing electricity, private streets, street names, existing septic systems, reserve septic areas for lots with existing septic systems, and existing water and sewer lines. Staff has talked with the utility providers about the wording of the certifications. A general discussion followed. By consensus the commission agreed a public hearing on amending the *Tellico Plains Subdivision Regulations* to incorporate these new certifications be held at the regular June planning commission meeting.
