### Continuing Education and Training RV parks and the Subdivision Regulations March 6, 2025

A public workshop was held at 5:00 p.m. in the boardroom of the Monroe County Courthouse to review the RV parks and mobile home parks resolution for potential amendments. Items discussed including but not limited to the following; separate the sections on RV parks from mobile homes parks starting with RV parks in the beginning of the document, referencing the most recent adopted flood maps, and Flood Resolution 1124-9, define time of stay for RVs as 30 days and address the role and authority of the enforcement officer, issues of people putting up tents to live in, proof of public water and waste disposal, permit applications and site plans. A spreadsheet comparing RV park regulations with other East Tennessee communities was handed out and discussed. The public workshop concluded at 6:00 p.m.
