CALL TO ORDER AND APPROVAL OF MINUTES

SPECIAL EXCEPTION, CONCEPT PLAN, PROPOSED RV PARK FOR 62 TENT AND RV SITES, CHRIS BROWN, HAROLD BROWN DESIGN, LLC, PROPERTY OWNERS, KENNETH MACK AND JACQUELINE O'CONNER, HWY. 411, TAX MAP 028, PARCEL 016.00 AND 016.02, C-3, HIGHWAY BUSINESS DISTRICT, APPROXIMATELY 8.76 ACRES COMBINED.

Adam and Nikki Moore were present with RV Park concept plan for 62 tent and RV sites, which would be first phase. Future goals included adding cabins, a playground, pool, office, dog park, store and other amenities.

VARIANCE REQUEST FROM HEIGHT REQUIREMENT FOR PROPOSED SELF-STORAGE FACILITY, APPLICANT, SUSAN SAUNDERS, PROPERTY OWNER, THE OVERHILL ELEVEN, HWY. 411, TAX MAP 037, PARCEL 046.00, C-3, HIGHWAY BUSINESS DISTRICT, APPROXIMATELY 8.9 ACRES.

Ron Whitaker, C2RL Engineer, was present with Susan Saunders to request height variance for proposed storage facility. Mr. Whitaker stated that the property is steep and they propose building a 2-story building with the side fronting on Hwy. 411 being a 1-story entrance with the 2nd story accessed from the rear of the building on the 2nd floor. The height of the building would be 20' instead of the maximum 18' requirement. The 2nd story would eliminate the exaction of rock which is on the property. Mr. Amschler stated the storage buildings may need to have a sprinkler system.

Mr. Davis moved to approve the variance which was seconded by Mr. Fowler and approved unanimously.
